PACKAGE INCLUDES: Seven nights in South Lake Tahoe choose between: **NOTE LIFT TICKETS ARE NOT INCLUDED IN THE BASIC PACKAGE** See Lift Ticket Information Below.

FOREST SUITES CONDOS: Located across the street from the Gondola, these condos feature either a 1 bedroom, 1 bath or 2 bedroom 2 bath condo each with a fully equipped kitchen, dining area, and living room. Property has two outdoor pools/hot tubs. Hot continental breakfast included each day.

MARGARITAVILLE RESORT (former Embassy Suites Hotel): Located 150 yds from the Gondola, these suites feature either 2 queen beds or 1 king bed with a separate living room. Each suite has a wet bar, coffee maker, mini refrigerator, and 2 flat screen TVs, Full breakfast included. Five restaurants onsite. Indoor heated hot tub and pool on premises

PLEASE NOTE: Transfers between Reno airport and lodging is included when booking air with NJSSC. Transfers for travelers who book their own air and arriving/departing Reno within one hour of the Council's flights will be permitted to take our transfer.

PACKAGE INFORMATION: The trip package includes two to four days at Heavenly, 1 day at Kirkwood, and 1 day at Northstar. Transportation to and from Kirkwood and Northstar is included. Also included are a race, welcome party, apres-ski party, and banquet. An optional side trip to Virginia City with a mine and trolley tour is also available.

LIFT TICKET INFORMATION: The Epic Local Pass is required to ski at Heavenly, Kirkwood, and Northstar and can be purchased on-line. Optional daily lift tickets include a two to seven day lift ticket good at 32 resorts. Lift ticket purchase is provided on the on-line reservation form. Those who purchase their day passes through this site and those who purchase or renew their full or local pass through this site will get a \$25 or \$50 rebate on their lift ticket purchase provided they book our trip (or other SkiGroup trip). Enter TRIPREBATE50 or TRIPREBATE25 in the Discount box at checkout to apply your instant trip rebate! Note that lift ticket prices will increase in price at some point and you must purchase at least a five day lift ticket to get the \$25 rebate.

PAYMENT SCHEDULE: A \$500 deposit due at sign-up, \$600 is due on July 1, 2026, and \$500 is due on October 1, 2026. Balance is due NLT December 1, 2026. Make your checks payable to New Jersey Ski & Snowboard Council, Inc. A 3% credit card fee will be added. Note that the non-member fee is \$75. If you join a NJSSC ski club the fee will be waived.

RESERVATIONS: All reservations must be made online. The online reservation site will provide all additional information, including single supplement cost, lift ticket options, cancellation policy, and trip insurance information. Emergency Contact and Liability Release forms, required for travel with the NJSSC, are also included online.

CANCELLATION POLICY: Written cancellation required. The following penalty will apply: Cancel from sign-up to 7/1/2026: \$25; from 7/2/2026 to 10/31/2026: \$500; from 11/1/2026 to 11/14/2026: \$700; from 11/15/2026 to 2/20/2027: full trip cost. A \$25 admin fee will apply if a substitute is provided from 10/16/2026 through 2/19/2027. Name changes once air is ticketed incur a \$150 change fee. Airline baggage policies apply.
